WEDDING PHOTOGRAPHY AGREEMENT

BOOKING DEPOSIT

A deposit of £250 is required at the time of booking. Your date is not reserved until this deposit is received. Please make cheques payable to Whole Picture Productions.

BALANCE OF PAYMENT

The balance is due 6 weeks before the date of the wedding.

Balance Mon-Thurs weddings *Snap Happier* £950 or *Picture Perfect* £1,550

Balance Fri-Sat weddings *Snap Happier* £1,150 or *Picture Perfect* £1,750

Payment for any additional prints, albums or extra services you may choose can be made later.

CANCELLATION

If you change your mind within seven days of making a booking with us, you may cancel your booking with an unconditional full refund of your deposit. If you need to cancel your booking at any time after this seven-day period, your deposit will not be refunded. In the event of us taking another booking for your cancelled date, the deposit will be refunded minus £50 to cover any correspondence, administrative work, or travel already carried out.

In the event that we have to cancel your booking for reasons beyond our control (death, injury, sickness etc.), our liability shall be limited to a full refund of all monies paid. We have a good network of contacts amongst other photographers, so should this unlikely event occur, we will endeavour to help you find a replacement photographer but naturally cannot make any guarantees in this respect.

CREATIVE LICENCE

Whole Picture Productions shall be granted creative and artistic licence in relation to the choice of locations and poses used. We will do our best to honour requests for particular photographs but due to weather conditions, availability and willingness of subjects, and time restrictions on the day, we do not guarantee to produce any specific picture, background, location or group arrangement.

VIEWING

Your photographs will be available to view and order via our website within three weeks of the date of the wedding. Other viewing options can be provided if necessary.

COPYRIGHT

The Copyright, Designs and Patents Act 1998 assigns copyright to Vince and Naomi Jones, trading as Whole Picture Productions. You may not copy photographs, or allow copies to be made, photographically, electronically, or by any other means. This agreement entitles us to the use of any photographs in promotional material. We provide all your files on disc; your rights of reproduction will be explained to you along with the disc.

LIABILITY

In the unlikely event of total photographic failure, injury or sickness beyond our control, our liability shall be limited to a full refund of all monies paid. We have full Public Liability and Professional Indemnity Insurance.
